An Update from the Greater London Authority

As you'll be aware, AELP London has been working very closely with the Greater London Authority (GLA) on the development of the capital's skills' and employability agendas. The following is a summary that the GLA has compiled for our Capital newsletter and provides an update on activity that has taken place over the summer months.

AELP London sits on the Skills for Londoners Board and its <u>Subordinate Bodies</u> which include:

GREATER LONDON AUTHORITY

- Skills for Londoners Higher Level Skills Advisory Board
- Apprenticeships Advisory Board
- Outcomes for Londoners Advisory GroupCareers for Londoners Steering Group
- Skills and Employment Vision Steering Group

We will continue to consult with London AELP members for input and provide updates on key areas and skills initiatives and policies in London.

Please find following some updates from the GLA regarding activities in London:

Apprenticeships including levy transfer

The London Progression Collaboration (LPC) will be launched in September 2019, focusing on better utilisation of the apprenticeship levy in the construction, retail and hospitality sectors. Two externally commissioned, 3-year programmes, aiming to utilise the apprenticeship levy in other sectors, will be launched late summer/early autumn.

Mayor's Construction Academy

Round 2 of the <u>Mayors Construction Academy</u> (MCA) hub funding will be launched in September 2019 to expand the hub network and broaden the remit to include infrastructure activity in relation to housebuilding. There will be three strands focusing on the expansion of the existing hub delivery, the development of new hubs and employment brokerage/referral partner support.

Higher skills

Officers are continuing to work to strengthen opportunities for Londoners to access higher level learning and training throughout their lives. The GLA are commissioning some Higher-Level Skills Research and currently have a call out for a research partner.

Careers

Officers are exploring taking forward workstreams identified in the <u>Careers for Londoners Action</u> <u>Plan</u>, and City Hall will once again be supporting this year's <u>Skills London 2019</u> being held at the ExCel in east London on 15th & 16th November.

Devolution - Adult Education Budget

August obviously represents a significant milestone for the GLA with the devolution of London's share of the Adult Education Budget (AEB) to the Mayor officially taking place.

After months of planning and preparing, it is an opportunity to reflect on the enormous amount of work that has taken place so far and to celebrate what has been achieved with our partners across the sector.

At the same time, we recognise that a huge amount of work lies ahead to realise the Mayor's ambitions for London's education and skills system. This can only be achieved through collaboration with the sector, that is why the GLA will continue to consult extensively on plans for the AEB now and in the future.

While the priority in Year 1 was always to make minimal changes to the AEB to provide stability to the sector, the Mayor has raised the financial eligibility threshold for learners to London's Living Wage as part of a wider commitment to ensure more adults in London can access the AEB, particularly those stuck in low paid jobs, with little chance to progress to better paid, more secure work.

The Mayor was also keen to give providers the opportunity to grow and develop their provision this year. To enable this, the Mayor will shortly launch the Skills for Londoners Innovation Fund, worth up to £6.4m, for grant-funded providers to bid for additional funding in 2019/20 (with the option to carry forward funding into 2020/21) to support projects that meet his priorities for skills and training in London, demonstrate innovation and are outcome-focused.

Training providers will have the opportunity to support potential bids where the proposed activity is specialist and/ or targeted at disadvantaged groups.

Vision

The Vision is now the *Call for Action*. The Mayor recognises that he cannot realise his ambitions through the AEB alone. That is why the Mayor and London Councils will renew calls for a new funding deal from government to establish an integrated, fully funded skills and employment system that can meet the city's challenges now and in the future.

The London Mayor's Manifesto - AELP London's submission

AELP London will be setting out a number of proposed areas aimed at helping to rebalance the skills system in London and proposes the following priority areas for consideration under the London Mayor's Manifesto for further education and skills training:

Apprenticeships

- Propose a healthy and sustainable long-term funding model
- A standalone non-levy apprenticeship budget
- Increase funding for Functional Skills under apprenticeships
- Financial Incentives
- Prisoner Apprenticeships and more broadly pathways to employment and skills training

Traineeships

Additional funding to support the relaunch, growth and promotion of Traineeships to support young Londoners progress into work, an apprenticeship or further education or training to enhance their productivity and social mobility.

Adult Education Budget (AEB)

Push for an increase in adult funding for Londoners to meet the ever-increasing demand in adult skills including literacy, numeracy, digital and first level 2 provision. There is an urgent need for leaders in the sector to create a level playing field for all provider groups and support the competitive procurement of the entire AEB in London (devolved and ESFA funded AEB), including grant allocations to ensure value for money.

UK Shared Prosperity Fund

Provide a clear statement of commitment and clarity on the future UK Shared Prosperity Fund (UKSPF) replacing the European Social Fund (ESF).

Careers

In our view, the current system is not reaching young people and adults in the way that it should, we think that the skills development of careers staff requires greater investment.

National Retraining

Ensuring there is adequate and equal additional participation funding available to all providers in London.

Value of Independent Training Providers

Champion raising the profile of Independent Training Providers (ITPs) within London.

London Devolution Update

You will be aware from various updates that delivery of the Adult Education Budget under the seven devolved areas went live on 1st August – click here for the <u>latest ESFA guidance</u>.

Specifically for London, see the latest update document titled, "<u>The exercise of delegated adult</u> education functions."

Following the GLA's procurement process, 29 providers have been awarded contracts (see list below) along with the grant providers – we await confirmation of the full lists which we understand from the GLA will be published in September.

Since they last joined us London Councils has published their Apprenticeship Report and received a response to their T-Levels submission.... so there will no doubt be much to chew over.

AELP Submission 69: Skills for Londoners Framework – AEB Consultation Year 2 (2020/221)

In this consultation paper we outline the main areas of proposed change to the AEB and set out a number of questions where we would welcome input from providers and stakeholders to inform our thinking as we continue to develop and shape the delivery of AEB services to Londoners.

AELP Submission 68: AELP Response – Greater London Authority (GLA) Consultation: Skills and Employment Local Industrial Strategy (LIS) Vision

AELP Best Practice Guidance

EPA/EPAO

Reasonable Adjustments – A Best Practice Guide

Many of the new Apprenticeship standards make reference to reasonable adjustments but stipulate that you should refer to the EPAO Reasonable Adjustment Policy. Having carried out a review these differ and in some cases do not yet exist, which does not give a valid, reliable and manageable approach to supporting individuals with support needs.

Pricing and Eligible Costs – A Best Practice Guide

There have been questions raised by providers and employers about what is included in an EPA price and what has to be paid for additionality. Furthermore, EPAO members have been concerned that providers and employers do not release the expectations as to who pays for what.

Subcontracting

The AELP Good Practice Governance Guide

Subcontracting has become an integral element of the FE system. It has grown and evolved mainly because of the changes to the funding system and policy development, and, as such, little has been written on what good practice looks like. To fill this vacuum AELP, Collab Group and HOLEX have worked together to produce a short good practice guide to support both the prime and subcontractor on the key principles of subcontracting.
